Each of the above components will be given a letter grade using the official university grading system (see <u>section F.1.1</u>). The final grade will be calculated using the grade point equivalents weighted by the percentages given above and then converted to a final letter grade using the official university grade point equivalents.

This course will have a Registrar Scheduled Final exam that will be delivered in-person and on campus. The Final Examination Schedule will be published by the Registrar's Office approximately one month after the start of the term. The final exam for this course will be designed to be completed within 2 hours.

Only the best 6 out of 7 exercises will be used to compute your course grade.

In order to obtain a final grade of D or better in the course, a student must achieve a grade of D or better on at least one of the midterm exam or the final exam. Failure to earn a D or better on one of these two exams will result in a grade of F in the course.

In order to obtain a final grade of C- or better in the course, a student must achieve a <u>weighted average</u> of C- (1.7) or better on the midterm and final exams. Failure to earn a C- weighted average on the exams will result in a grade of D+ or less in the course. Please be advised that a grade of C on the midterm exam combined with a grade of D+ on the final exam does **not** result in a C- weighted average across the two exams because the final exam is weighted more heavily than the midterm.

Students who achieve a higher grade on the final exam than on the midterm exam will have their midterm exam grade replaced with their final exam grade.

- Describe and summarize the roles of programming and computing in a broader context of topics that may include scientific and non-scientific computing, data storage and analysis, established sub-disciplines of computer science, history of computing, or social and philosophical issues.
