This course introduces machine learning techniques commonly used in data science, such as classification, clustering, visualization and analysis of data.

- Statistics (Statistics 213 or another course with probability)

### 3. **Grading:**

In determining the overall grade in the course the following weights will be used:

Component(s)	Weighting %	Dates
Assignments (individual work)	30%	Throughout the term
Midterm exam (individual work)	20%	March 16th
Course Team Project (team work, grades assigned individually)	50%	Last four weeks

The midterm exam will be open book, 1 hour long, and it is to be completed during the scheduled class time on March 16th starting at 12:30pm Mountain Time. Students will complete the exam online, and will be given an extra 0.5 hours of buffer time for any technical issues.

Course Team Project is further divided into the following:

Component(s)	Weighting %	Dates
Team formation	0%	March 11th
Project plan presentation	20%	March 23rd and March 25th in class
Project final presentation	30%	April 13th and April 15th in class
Implemented learning system	20%	April 15th
Individual system report	30%	April 15th

Each of the above components will be given a letter grade using the official university grading system (see [section F.1.1](#)). The final grade will be calculated using the grade point equivalents weighted by the percentages given above and then converted to a final letter grade using the official university grade point equivalents.
