1. **Course:** DATA 601, Working with Data and Visualization - Fall 2021

An introduction to fundamental data science concepts including basic data organization, data collection, and data cleaning. Includes a review of basic programming concepts in Python, as well as an introduction to the fundamentals of data visualization and critical thinking with data.

Online Delivery Details:

Some aspects of this course are being offered in real-time via scheduled meeting times. For those aspects you are required to be online at the same time.

To help ensure Zoom sessions are private, do not share the Zoom link or password with others, or on any social media platforms. Zoom links and passwords are only intended for students registered in the course. Zoom recordings and materials presented in Zoom, including any teaching materials, must not be shared, distributed or published without the instructor's permission.

The course will be conducted online in a hybrid format.

Class will have two components:

1. Asynchronous Component (9AM - 10:30AM):
This consists of a series of video clips, course readings and practice problems that will be made available to students prior to the beginning of class. Students are expected to spend at least 75 minutes per class reviewing this material before the synchronous component.
2. Synchronous Component (10:30AM - 11:45AM):
This consists of a 75 minute live lecture (conducted via Zoom) to be held starting at 10:30 AM. During this live component of the class, an extensive review will be held where students will have the opportunity to ask questions and work through - with colleagues - various exercises. Students will have instructor support as well as teaching assistant support during this live component of the class.

2. **Requisites:**

Prerequisite(s):

Admission to the Graduate Certificate in Fundamental Data Science and Analytics, or the Graduate Diploma in Data Science and Analytics, or the Master of Data Science and Analytics.

In order to successfully complete the assignments and deliver a final project, you should have the following prerequisites.

- Mathematical maturity (Calculus and/or Linear Algebra).
- Prior exposure to computer programming is expected. You are not required to know Python. The initial portion of the course will introduce the necessary basic and intermediate Python constructs that you need for this course. This material will be delivered at a fast pace and is geared towards those who already know how

to program in a procedural programming language.

3. Grading:

In determining the overall grade in the course the following weights will be used:

Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.
