# Purpose:

The purpose of this research is to understand how distance-separated couples use video communication systems such as those found in Skype, Microsoft Messenger, or other systems, to maintain their intimate relationship. This includes understanding when and how couples engage in video communication together and what activities they participate in while video conferencing. We will use this knowledge to better design video conferencing and communication technologies to meet the needs of distance-separated couples.

### **Participant Recruitment and Selection:**

To be recruited for this study, you should be comfortable describing intimate details regarding your relationship with your partner and the (possibly intimate) activities you do online with your partner.

# What Will I Be Asked To Do?

Through a survey, and interview, we will ask you questions such as: your personal situation with your partner; where, when and how often you see each other physically vs. via video conferencing, what activities you engage in while using video conferencing with your partner (this will include intimate questions), how video technology helps and hinders these activities, and other methods that you use to communicate with your partner.

Optional. We will also ask you to participate in a diary study. If you agree, you will keep a 'diary' with you, where you will record and summarize your use, activities and thoughts you may have as you use your video system with your partner over a period of a month. After the study is complete, the researchers will keep the diary.

#### **Your Participation**

Participation is voluntary. If you agree to participate, you will be free to withdraw at any time for any reason. However, data collected up to that withdrawal point may still be retained and used by the researchers.

### What Type of Personal Information Will Be Collected?

Your anonymity will be strictly maintained. The only personally identifying information collected will be your name, which will be used for administration of payment. Any data collected will be labeled with an anonymous participant ID. Because we will audio-record your interview, this recording will be electronically manipulated afterwards to mask the speaker's voice, and/or transcribed after which the recording will be erased. If you participate in the diary study, your diary will also be kept confidential; we will also ask you to use pseudonyms rather than real names of you and your partner.

### Are There Risks or Benefits if I Participate?

The risks of participation are intended to be none or minimal. However, because we will be asking you personal questions, there is risk of feelings of emotional discomfort such as embarrassment, and/or concerns about privacy. To mitigate this, you can choose what information you are comfortable revealing. As mentioned, we will scrupulously anonymize all data to mask your identity. If participating in face-to-face interviews or interviews over communication tools (e.g., email, Skype), your identity will be known by the investigators and thus we cannot guarantee confidentiality in this regard. Communication tools such as Skype attempt to ensure data security through encryption technologies. While beneficial, there are still possibilities of risk associated with using such a medium (e.g., hackers acquiring data).

You will be paid \$30 for your participation in the interview. Should you decide to withdraw before completion, the payment will be reduced by pro-rating it to the time actually spent.

If you participate in the diary study, you will be paid another \$20 upon handing in your diary, although this amount will be pro-rated if there are less than 20 detailed entries in the diary.

# What Happens to the Information I Provide?

No one except the researchers and their assistants will be allowed to see or hear any of the answers to the questionnaire or the interview tape. No names are recorded on the questionnaire or diary. Only group information will be summarized for any presentation or publication of results. The questionnaires and diary are kept in a locked cabinet only accessible by the researcher and her supervisor. The anonymous data will be stored for three years on a computer disk, at which time, it will be permanently erased.

All data collected as part of the study will be kept on a secure server computer in Canada

We expect to publish reports and presentations describing this research. Public presentations of the results will primarily present the results in an aggregate form or as caricatures that are composites of one or more participants. Where individual participant data is disclosed, such as exemplar interview comments or diary entries via quotes, we will ensure that the selected data does not suggest
